# **EXECUTIVE SUMMARY**

This Deliverable 7.1 provides information on the design and implementation process of the ELISAH project website, from its structure to its visual identity. The document includes a summary of the different sections and contents that can be found on the website, as well as a description of the work plan. This document complements Deliverable 7.2, which contains the Dissemination and Communication Plan. The website referred to in this document can be found at <u>https://elisah.eu/</u>

## **1. INTRODUCTION**

The ELISAH project aims to reduce the burden of breast cancer by acting on modifiable risk factors and involving NGOs and patient groups. It will develop different strategies that integrate structural interventions and individual health promotion, and the relationships between risk factors. The project is articulated around studying environmental pollution, the built environment, exposure to unhealthy nutrition, lack of physical activity, as well as alcohol and tobacco use.

The ELISAH project is designed to complement the Joint Action on 'Cancer and other NCDs prevention – action on health determinants and aims to fill the gap between the vast number of published results, the lack of knowledge about the distribution of risk factors in the population and the need for research implementation to translate scientific evidence into population health improvement.

The communication and dissemination activities of this project will be developed in awareness campaigns to be able to spread the action and its results, as well as bring awareness to this important issue and the current unmet needs.

This deliverable outlines the webpage work which is part of the Dissemination and Evaluation work package 7. The actions carried out regarding the creation and content of the website and the visual identity design of the ELISAH project are summarized below, which is also described in more detail in Deliverable D7.2.

## **2. WEBSITE**

The ELISAH project website is the most relevant communication and dissemination point. The website can be consulted at the following address www.elisah.eu and has been designed and implemented in collaboration with work package (WP) 1 - Management and Coordination. The website has been developed by LifeCharger Srl and will be maintained and updated throughout the duration of project.

#### 2.1 **PROJECT IDENTITY**

The visual identity of the ELISAH project was chosen by a vote of its members from among different proposals presented, as explained in more detail in the Deliverable D7.2 – Dissemination and Communication Plan.

The website is designed according to the visual identity of the project, with the logo visible always and using the fonts and colors specified in the ELISAH project visual identity guide.

#### 2.2 STRUCTURE

In order to define the structure of the website, a benchmarking process was carried out by identifying the content of the websites of different operational European projects, as shown in Figure 1. After this process, it was decided to implement 5 tabs with content and their sections, in addition to Home and the different extras described below.

#### 2.3.1 HOME

The **Home** page is designed to start with an animation of the project logo. The main part shows a timeline (Figure 3) with the main milestones of the project, as well as various links to other sections of the website where you can learn more about ELISAH.

#### 2.3.2 PROJECT

The **Project** tab is designed to provide an overview of the project's goals and structure. Specifically, it contains an explanatory text about the project and a summary of the different WPs, each of which has a link to its own page detailing the specific objectives of each of them, with an associated infographic and a link to the page of the WP



coordinating institution as can be seen in Figure 4.

In addition, the main part of this tab contains a description of the ELISAH consortium and a summary of the expected results of this project.

#### 2.3.3 CONSORTIUM

The **Consortium** section is divided into two sections, the one that describes each of the partners of the ELISAH project and the one that describes the affiliated entities. For each of the institutions participating in the Consortium, a specific page has been created that summarizes the nature and function of each institution and includes the list of researchers participating in the project.

#### 2.3.4 COMMUNICATION

Regarding the **Communication** section, it has been specifically divided into 5 sections:

- a. Events
- b. Newsletter
- c. Project material
- d. Public deliverables
- e. Abstracts & Publications

Each of the sections will be fed with content as it is created. Regarding the newsletter, as indicated in the Communication Plan, 1 per semester is planned. On the other hand,



regarding the Public Deliverables, a table has been created with the list of each of them and they will be uploaded to the website as they become available.

#### **2.3.5 BE INVOLVED**

The **Be Involved** section is intended as a gateway to participate in the activities promoted by WP4 of the project. This WP aims to develop a digital platform, including a mobile app for patients and citizens and a web dashboard for health professionals and researchers, to support women's engagement in the lifestyle change intervention, activity tracking and monitoring, data collection and sharing.

This section of the website will not only provide information on this aspect of the project but will also provide access to the digital platform and all related content.

### **3. WORK PLAN**

The design and implementation of the website was planned for the first six months of the project. The first three months were used to determine who would be responsible for the implementation and to reserve the domain.

From the third to the sixth month, the website was designed in stages in coordination between WP7 and LifeCharger Srl through regular virtual meetings. First the main body and then the content of each section. In Annex 1 you can see some screenshots of the design process.

The work plan from month sixth is as follows:
